The Kenya management team works on a budget every October with the BEAM Kenya Executive Director. This budget is first approved by the BEAM Children's Foundation board and then sent to the BEAM Kenya board for final approval. Although BEAM Kenya has no legal authority over BEAM Children's Foundation, the U.S. board has the right to vote on the finances that are sent over to Kenya and review any possible concerns. There is no legally binding relationship between the two organizations.
